Ms. Neiderer presented an overview of the Adams County Long Range Transportation Plan entitled Onward2050. This overview included priorities, goals, and objectives of the plan as determined by public survey. This included a discussion on how future transportation projects would be prioritized. Also discussed were some other technical details that guided the planning process including environmental justice/equity, locations of environmental and cultural resources, and air quality conformity.
