1. Introductory Comments

Mr. Laughman called the meeting to order at 1:00pm. It was established that a quorum was present. No items were added to the agenda.

2. Approval of Minutes – July 27, 2022

Mr. Strayer motioned to approve the minutes. Mr. Martin seconded, and the minutes were approved by a unanimous vote.

3. Staff Updates – ACOPD

- a. Mr. Merkel reported that staff attended the following HOP/Traffic Study/Project meetings since the last ACTPO board meeting:
 - SRTP/PA Commuter Services Board meeting
 - SRTP/PA Commuter Services Long-range Strategic Planning meeting
 - PennDOT Fall Planning Partners meeting
 - 2023-2026 TIP PennDOT Connects project meetings (10 total)

Mr. Merkel also discussed a new staff update agenda item titled Developments of Significance that will be forthcoming starting in 2023. This report would show new developments over a certain size proposed in Adams County. He noted that staff felt such a report would be more thorough and beneficial than the current reporting focused only on HOP/Traffic Study Meeting.

- Mr. Cameron noted that inspections of weight limited bridges were ongoing. He also discussed
 a letter received by ACTPO from Latimore Township regarding a Township bridge on Ridge Road
 over Latimore Creek that recent inspections showed deterioration sufficient to warrant a change
 in bridge condition status. A short discussion ensued regarding the timing of inspections. Mr.
 Hazlett raised a question regarding the timing of potential candidate projects.
- c. Mr. Merkel presented a comparison of the outcomes of the 2023 TIP and ONWARD2050 Long Range Plan public participation efforts. He noted that despite a significant financial outlay for print advertising, there were only two attendees total (in-person and virtual) at a combined four (4) public meetings. Additionally, he noted that only 1 out of 28 comments received could be directly traced to the print advertising while 18 of 28 could be traced to online or email outreach efforts. A discussion ensued about this trend. Mr. Merkel noted that this data would be used to shape ACTPO's forthcoming Public Participation Plan (PPP).
- d. Mr. Merkel discussed the 2023-2026 PA STIP Planning Findings. He noted these are prepared by FHWA as an after-action-review item of sorts to identify process from around the Commonwealth that work well and identify areas where additional focus and efforts are needed.
- e. Mr. Merkel discussed the PennDOT Multimodal Transportation Fund (MTF) application round, noting the submission deadline was November 14, 2022.
- f. Mr. Merkel discussed the Pennsylvania National Electric Vehicle (NEVI) Plan. He covered some basics on charging technology and which road corridors have been identified as Alternative Fuel Corridors, including US 15 and US 30 in Adams County.

4. Transit Update

a. Ms. Nidam reported on ridership, local rebranding efforts and shared ride/same day service launching efforts.

5. Presentation by Commuter Services of Pennsylvania

Ms. Newcomer gave a presentation on the Commuter Service of Pennsylvania. She noted the overall program purpose, goals, employer/employee tools and commuter perks offered through the program.

6. Presentation on 9/11 National Memorial Trail

Mr. Hickethier gave a presentation on background of the 9/11 National Memorial Trail and its tie-ins to Adams County. Maps of the proposed trail route through Adams County were shown. Examples of signage to be installed along the route were also displayed. Ms. Angstadt noted that GIS maps of proposed sign locations had been prepared. Mrs. Clayton-Williams noted that outreach to municipalities along the route would occur soon. Mr. Laughman asked if the route would involve walking paths. Mr. Hickethier indicated no such paths were planned. Mr. Serpe noted community support for the 9/11 Trail, the Grand History Trail and potential connections between Gettysburg and Hanover and Gettysburg and Emmitsburg.

7. 2021-2024 TIP Update – PennDOT, Adams County

a. Mr. Puher noted that there were two administrative modifications made to the 2021-2024 TIP prior to the end of the 2021 TIP before the start of the 2023 TIP. It was also noted that the SR 116 Bridge action involved funds from the annual August redistribution of obligation funds. There is no vote required for administrative modifications.

8. PennDOT Comments

- Mr. Reisinger gave a brief update on the Eisenhower Drive project, noting that the submission to FHWA was almost complete to submit for a possible decision and finding. He also noted that Final Design would hopefully move forward in 2023. In response to a question regarding construction timeline for the project, he noted that summer 2025 would be more realistic.
- Mr. Mullins and Mr. Green responded to a question regarding interactions between PennDOT and FHWA and PennDOT and FTA. Brief summaries of the roles of each agency were discussed.

9. FHWA Comments

 Ms. Bishop noted that in addition to the summaries provided by Mr. Mullins and Mr. Green, FHWA also assists PennDOT and MPO's with determining eligibility for federal funds. She also provided a link to a US DOT report on public involvement. Finally, she noted that the Thriving Communities grant program was recently opened.

Introduction

In accordance with 23 CFR 450.334, this document will identify the projects that received obligated federal funding during the Federal Fiscal Year (FFY) 2022 covering October 1, 2021 to September 30, 2022. The Federal Highway Administration defines 'obligated' as "the Federal government's promise to pay a State for the Federal share of a project's eligible cost." These funds are typically a portion of the overall project cost. The overall funded project cost generally consists of Federal funds and funds matched from other sources obtained by the State or local project sponsor.

In some instances, the obligated funds for a project become de-obligated as a result of lower than expected costs, project removal or withdrawal, and other factors. In most cases negative obligations return to the budget's bottom line to be utilized for other projects. De-obligation amounts in all tables throughout this document are identified in red and parentheses.

Figures included in this report only apply federal dollars to referenced projects. Projects may also include state and/or local funding that is not reflected in project totals.

The FFY 2021 Transit Annual List of Obligated Projects table is located at the end of this document.



FFY 2022 Summary

The following report lists all transportation projects in the Adams County MPO in which federal funds were spent in federal fiscal year (FFY) 2022. The total amount of federal funding obligated to projects in the region during FFY2022 was \$9,664,325 covering 11 projects. This represents an increase of108% (\$5,028,528) in obligated funds in comparison to the amount reported from the FFY 2021 obligation report of \$4,635,797). There was a total savings of \$2,747,848 due to completion of projects which were deobligated.

In FFY 2022, 58% of all obligated funds were for federal bridge projects, followed by highway projects at 17%, safety projects at 13%, bike/pedestrian at 8%, and transit projects at 4%. All the de-obligated funds represented federal highway projects. A summary listing of the funding amounts can be found in the table below and distribution of funding is illustrated in the pie chart, also found below. A more detailed listing of projects can be found on the next page.



Dear Planning Partners:

Pursuant to the code of Federal Regulations (23 CFR § 490) regarding National Performance Management Measures for the Highway Safety Improvement Program (HSIP), Pennsylvania has established the 2023 targets for the following Safety Performance Measures:

- 1) Number of fatalities
- 2) Rate of fatalities per 100 million Vehicle Miles Travelled (VMT)
- 3) Number of serious injuries
- 4) Rate of serious injuries per 100 million VMT
- 5) Number of non-motorized fatalities and serious injuries.

The Pennsylvania Department of Transportation (PennDOT) is required to establish these targets by August 31st each year. The 2023 targets found in Table 1 of the enclosure are based on a data driven trend analysis of the statewide fatality and suspected serious injury numbers (2 percent annual fatality reduction and maintaining level suspected serious injuries).

Metropolitan Planning Organization (MPOs) are required to establish targets within 180 days of PennDOT establishing its targets (by February 27, 2023) either by agreeing to plan and program projects in support of the PennDOT targets, or by establishing their own quantifiable targets. For consistency, PennDOT is requesting Rural Planning Organizations (RPOs) follow the same procedure. MPO Boundaries and Coordination of Transportation Planning and Programming between York Area Metropolitan Planning Organization (YAMPO) and Adams County Transportation Planning Organization (ACTPO)

I. Background and Purpose

- a. The Year 2010 Census defined Urbanized Area (UA) for Hanover extends into Adams County along the US Route 30 corridor and includes a part or all of the Boroughs of Abbottstown, New Oxford, and Gettysburg. By federal statute, an MPO, or coverage by adjacent MPOs, is required where there is an Urbanized Boundary.
 - i. Upon release of the geodata, the Year 2020 Census defined Urbanized Area (UA) for Hanover will take place of the current 2010 Census defined Hanover Urbanized Area.
- b. The York Area Metropolitan Planning Organization (YAMPO) and the Adams County Transportation Planning Organization (ACTPO) recognize that the Hanover, Pennsylvania Urbanized Boundary extends into Adams County, Pennsylvania. The purpose of this agreement is to define the roles and responsibilities of the Metropolitan Planning Organizations (MPOs).
- c. This agreement provides the framework for the responsibilities of the YAMPO and ACTPO relative to the federally mandated transportation planning, programming, and funding for the Hanover Urbanized Area within Adams County. Each MPO will coordinate with the other on planning and programming of studies and projects that will affect the economy, environment, transportation systems, and quality of life for the citizens within their respective planning areas.

II. General Points of Understanding and Agreement

- **a.** We agree to collaborate in the planning, conduct, and reporting of transportation-related information at the state and regional levels. We agree to share information and plans in order to achieve the goals of state and regional transportation plans, and to assist, where appropriate, in the joint selection of projects, and improve the coordination of investment across borders.
- **b.** We agree to work together to achieve compliance with all applicable federal planning regulations and guidance. We will work collaboratively to address the certification review that take place every four years, as scheduled by the U.S. Department of Transportation Federal Highway Administration and Federal

Transit Administration – Region 3, in order to continually improve upon our transportation Planning processes.

- **c.** We agree that staffs of both MPOs will meet as needed to review progress of cooperative efforts, to discuss key findings from program activities, and to discuss the scope, plans and implementation of activities under consideration for the next planning cycle.
- **d.** This agreement will be reviewed when either agency identifies the need for review.

III. Specific Points of Understanding and Agreement

- a. MPO Boundary
 - i. The York Area MPO/Adams County MPO boundary is now and has been coincident with the common boundaries between York and Adams counties (and by this MOU is proposed to remain so).
- **b.** Long Range Transportation Plans (LRTP)
 - i. We recognize the currently adopted GOYORK 2045 Metropolitan Transportation Plan (MTP) the transportation plan for York County, Pennsylvania. This includes the portion of the Hanover Urbanized Area in York County.
 - ii. We recognize the currently adopted ONWARD2050, Adams County MPO Long Range Transportation Plan, is the transportation plan for Adams County, Pennsylvania. This includes the portion of the Hanover Urbanized Area in Adams County.
 - **iii.** We agree the York County MPO will address the planning and programming needs of the Hanover Urbanized Area within York County. Findings of the York County MPO concerning its portion of the Hanover Urbanized Area will be incorporated into the Long Range Transportation Plans for both MPOs.
 - **iv.** We agree the Adams County MPO will address the planning and programming needs of the Hanover Urbanized Area within Adams County. Findings of the Adams County MPO concerning its portion of the Hanover Urbanized Area will be incorporated into the Long Range Transportation Plans for both MPOs.
- **c.** Transportation Improvement Program (TIP)
 - i. We agree to work together on planning and programming projects for the Hanover Urbanized Area within Adams County and assure that applicable funds are spent on projects and programs that improve the transportation system.

- ii. We agree to work together on planning and programming projects for the Hanover Urbanized Area within York County and assure that applicable funds are spent on projects and programs that improve the transportation system.
- iii. To help ensure continuity of federal and state funds and help support project delivery, i.e. Transportation Improvement Program, both the York County MPO and Adams County MPO agree to abide by the methodology and process used within Pennsylvania to allocate federal and state funds to the respective MPO's. The federal and state formulas will continue to follow county boundaries and not by the Urbanized Area Boundary. Surface Transportation Program Urban (STU) funds will not be divided between the York and Adam's County MPOs. Congestion Reduction Funds will be divided between the York County MPO and Adams County MPO based on the percentage of the Hanover Urbanized Area population within Adams County and York County as parts of the entire Hanover Urbanized Area population. Such funds will be used for projects in each County's portion of the Hanover Urbanized Area.

d. Unified Planning Work Program (UPWP)

- As part of the UPWP process, the Adams County MPO and York County MPO will develop and submit a work plan for all work related to the use of the Congestion Reduction Funds within their respective portions of the Hanover Urbanized Area.
- ii. To help ensure the continuity of federal funds and help support the planning process between the two existing MPO planning area boundaries, each agency agrees to abide by the methodology and process currently used to allocate planning funds to the respective MPOs.

e. Other Planning Activities

- i. We agree to work together to identify the need for corridor projects that cross the MPO boundary.
- ii. We agree the Adams County MPO will address urban area boundary issues and review the functional classification of all public roads and streets within Adams County. This review will be completed using the National Function Classification System guidelines.
- iii. We agree the York County MPO will address urban area boundary issues and review the functional classification of all public roads and streets within York County. This review will be completed using the National Function Classification System guidelines.
