**CHARGES FILED IN CHILD PORNOGRAPHY CASE**

Adams County District Attorney Brian Sinnett announced today that charges have been filed against David Anthony Valenca, 22, of Greencastle, Pennsylvania for Possession and Dissemination of Child Pornography. *Please see attached Criminal Complaint and Affidavit of Probable Cause.* This investigation was led and charges were filed by Adams County Detective Eric Beyer, of the Adams County District Attorney's Office. Detective Beyer was assisted by members of the Eastern Adams Regional Police Department, the Pennsylvania Office of Attorney General and the Homeland Security Investigations Division. District Attorney Sinnett wishes to thank all the collaborating agencies for their help in this investigation.

District Attorney Sinnett indicated, "This office remains committed to the investigation, prosecution and efforts towards eradication of the sexual abuse of children which continues to occur far too frequently in our community. All available resources, technology, and collaborative efforts will be used in this endeavor."

In this case, as with all criminal cases, the defendant is presumed innocent until proven guilty.

## AFFIDAVIT of PROBABLE CAUSE

I, Detective Eric B. Beyer of the Adams County District Attorney's Office, believe the following information to be sufficient probable cause to charge David Anthony Valenca II with the offenses listed on the attached and incorporated Criminal Complaint.

On 25 February 2020, I received NCMEC Cybertip 62475285, a report from Snapchat, from the Delaware County District Attorney's Office as a passthrough from the PA ICAC Task Force. In this report, Snapchat informed the NCMEC that a user had uploaded three images of child pornography and one image of child erotica during a chat. Snapchat provided user information as outlined below:

Snapchat provided the images, which I personally reviewed, and found images depicting females under the age of 13 years old engaged in nudity, with their nude breasts, buttocks, or vaginal areas lewdly displayed. One image depicted a female child under the age of 13 having been engaged in sexual, indecent, contact.

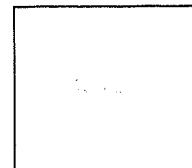

**AFFIDAVIT of PROBABLE CAUSE CONTINUATION**

A search was performed in ARIN of the IP Address 98.235.22.50, which resolved to Comcast Cable Communications. As a result of the aforementioned information, on 25 February 2020, an Administrative Subpoena was forwarded to the Comcast Legal Response Center for the subscriber information for the IP address 98.235.22.50.

On 26 February 2020, I received records created within the normal course of business from the Comcast Legal Response Center, which indicated the following subscriber information for IP Address 98.235.22.50 on the date and time of the download:

After receiving this record, I contacted the United States Postal Inspectors Service and inquired as to anyone receiving mail at this address. On 27 February 2020, I received information from Sharon Miller, USPIS, which indicated that Barbara Warner and David Valenca II are receiving mail at 3 Hampshire Drive, New Oxford, PA, 17350. A check of PennDot records indicates that David Anthony Valenca II has a valid license with a listed address of 41 N. Allison St., Greencastle, PA 17225. David Anthony Valenca II's date of birth is 9/21/1997, which is the date of birth listed for the user reported by Snapchat to NCMEC as having uploaded the four described images of child pornography.

Based upon this information, on 10 March 2020, a search warrant was served on 3 Hampshire Drive, New Oxford, PA 17350. Also on this date, an interview was conducted of David Anthony Valenca II at his place of employment, the North Hanover Mall. During this interview, David Anthony Valenca II admitted to using his cellular phone to share child pornography, which he had accessed via Dropbox. He further admitted that he shared these links using Snapchat. Valenca admitted that this child pornography was kept for sexual gratification, and he had engaged in masturbation while viewing said child pornography.

**AFFIDAVIT of PROBABLE CAUSE CONTINUATION**

A forensic examination was conducted of Valenca's Apple iPhone, during which 225 images of child pornography were located. These images depicted children as young as infants and toddlers being engaged in unlawful sexual contact. An additional 182 images of child pornography depicting children appearing to be under 13 years of age engaged in the lewd and lascivious display of their nude breasts, buttocks, and/or genital regions were also located within said phone.

During my review of this forensic report, I observed a Dropbox account associated with this phone, with an associated email address of dannyman2@gmail.com. The complete forensic report showed that this phone was used to store files in the Dropbox account, and showed a file that was only visible to the possessor of the phone, titled "Y1". Thumbnail screenshots of the images and videos in this file were visible and depicted child pornography.

On 13 March 2020, I served a search warrant on the aforementioned described Dropbox account. On 22 May 2020, I received the content of this Dropbox account. The Dropbox account 2227382016, with the associated user name "Dan Van", and associated email address of dannyman2@gmail.com, had 41 items separated into a folder called Y1. 10 videos located within this folder depicted females under the age of 13 years old engaged in unlawful contact, including vaginal and oral sexual contact. One of these videos depicted the juvenile victim engaged in bondage activities. Included in this folder were the images reported to NCMEC by Snapchat, which David Valenca admitted to possessing.

Also on 13 March 2020, I served a search warrant on the Snapchat account reported by NCMEC. On 18 March 2020, I received records from Snapchat, including the content of this account. My review of this report found six images of child pornography, including the images reported during the initial NCMEC CyberTip, which were shared from the IP address located in Adams County, PA. In this chat, the Snapchat account associated with David Valenca indicated that he has a Dropbox account with more images.

The use of a smart phone, in this case the defendant's iPhone, in combination with the internet, and internet social media as well as cloud based storage, for the purposes of storing, possession, disseminating, and viewing child pornography is a violation of Title 18, Section 7512, Criminal Use of a Communication Device.

Based upon the above stated information, I ask that David Anthony Valenca answer to the charges set forth.
