2025 General Election

It is gratifying to report that turnout was unusually heavy for this election with 40% of Adams County voters either voting early or casting their vote at the polls. School Board, Adams County Court of Common Pleas, State Supreme Court retention, and Municipal contests generated high interest. Of the 30,003 votes cast, 8,333 were by early voting. That equates to 27% of Adams County voters choosing that voting method.

As I visited numerous polls around Adams County on election day, the process went very smoothly with no waiting, and poll workers and voters overwhelmingly embracing the poll pads that were at every polling place. The polling pads expedited the name look-up and significantly decreased the calls to the Election Office to look up voters who were not in their books. We observed that the poll pads have resulted in the need to create more voting stations at some polls. Our election staff will make that adjustment moving forward.

Due to State Representative Torren Ecker being elected to the Adams County Court of Common Pleas, there will be a special election this Spring or during the next Primary Election to fill that seat - which will be determined by the legislature. There were also numerous municipal offices such as Judge of Elections, Auditor, Tax Collector, and Inspector of Elections that resulted in tie votes. On Friday, November 21

at 12:00 there will a "casting of lots" in the historic courtroom to determine the winner of each position. The winner will be notified by the Elections Office and must formally accept the position to be seated.

Adams County 2026 Tentative Budget Approved

At Wednesday's public meeting the Adams County Board of Commissioners passed the 2026 Tentative/Proposed County Budget totaling \$98, 982,261. The budget did not include any tax increase! The General Fund totaled \$78,193,036, the Special Funds (911/CYS) \$16,253,497, Bridge Fund \$882,000 and the Hotel Tax Fund \$3,653,860. The increase in Expenditures over 2025 was 7.2%, while the increase in Revenue was only 1.2%.

With Adams County being in a solid financial position, the difference this year is bridged by \$5,580,182 in Reserves. Salaries, benefits, health insurance and cost of goods/services were the main drivers in the disparity for this budget. Four years ago, the Board began budget visioning in 4-year blocks, and this is the first year of the new cycle. Even though Adams County is in a good financial position, has ample reserves, and the highest credit rating, we are hopeful the economic stresses that surfaced this year moderate to allow expenses and revenue to return to a more normal climate.

A copy of the Tentative/Proposed Budget is on the Adams County website and a counter-copy is in the Commissioner's Office. Thank you to our Budget Department, Adams County Fiscal Team, Department Directors and Commissioners Staff for their year-long effort to put forth a budget that allows superior service to our Adams Couty residents, while being ever cognizant of our responsibility to taxpayers and their tax dollars!

2025 Adams County Tax Appeals Concluded

The Commissioners, in their role as the Adams County Board of Assessment Appeals, along with an appointed Auxiliary Appeals Board, recently finished up hearing property tax appeals. This year, the County scheduled a total of 99 appeals in which the Commissioners heard 64, including commercial/industrial, Clean and Green, catastrophic loss and tax exemption appeals, while the auxiliary board heard the remaining residential appeals. The number of appeals this year increased slightly, mostly due to higher-than-normal exemption requests, but for the most part, continuing the downward trend from approximately 10,000 coming right out of the 2010 countywide reassessment; to 387 in 2015; 120 in 2020; and 88 last year.

Adams County Assessed Property Value Total

At Wednesday's public meeting Tax Director Daryl Crum reported the annual compilation of County property value. The Assessed Value of Real Property is \$10,392,911,000 (that's billion)! The Value of Occupations is \$17,792,200. The Number of Persons Subject to Personal Taxes (Per Capita) is 78,845.
