The October 1, 2025 meeting of the Adams County Agricultural Land Preservation Board commenced at 7:01 pm in the Planning Conference Room at the Adams County Agricultural & Natural Resources Center.

### I. Board Business

A. Approval of September 3, 2025 Meeting Minutes

Mr. Waybright made a motion to approve the September 3, 2025, ACALPB minutes; Mr. Nell seconded the motion. Motion was approved unanimously.

- B. Public Comments/Updates/Announcements
  - 1. Staff Updates/Meetings
    - a. Ellen updated the Board on Craig Yingling.
    - b. Ellen and Mark attended the Cumberland County celebration of 25,000 acres on Tuesday, September 16th. It was held at the Lil' Ponderosa Beef Farm and attended by over 100 people.

## D. Legislative Updates/Issues

- 1. PA Farm Bureau Updates (Mark Clowney, Dave Wenk) none
- 2. HB 1059 Regarding non-profit organizations receiving reimbursements

Land Trust Bill. This bill would direct a portion of the state-allocated farmland preservation funding to be set-aside for Land Trusts if farms meet all state minimum requirements. Reimbursement of transaction expenses would be raised to \$10,000/easement from \$5,000. PFPA will be taking action on this bill at their November meeting.

Mr. Nell made a motion to oppose the bill with the exception of raising the transaction expenses from \$5,000 to \$10,000; Mr. Mearns seconded. Motion carried.

3. HB 1584 – Regarding preservation of tracts less than 10 acres and adjacent to other preserved farms being eligible for preservation. The current law does not permit parcels less than ten acres. This law would permit less than 10 acres if it is adjacent to a preserved farm and is being made part of that parcel. In addition, the legislation would protect these subdivisions from Clean and Green roll-back penalties.

Mr. Nell made a motion to support Bill 1584; seconded by Mr. Waybright. Motion carried.

## II. Updates

- A. Township Updates Mt. Joy Township approved to consolidate the two parcels into one deed on the Kinsella Farm. We should be able to settle on this easement in the next month.
- B. LCAC Updates (Mark) Hanover Shoe Farm will be donating the easement on a 19-acre parcel to the LCAC.
- C. Parks, Recreation and Green Space Grant Program

Annual meeting was September 16, 2025. Kelly received four park applications and five Ag Land and Open Space applications.

All applications were approved by the PRGS Committee, and we are awaiting approval from our Assistant Solicitor. Once they receive approval from the Assistant Solicitor the projects can be approved by the Commissioners at a public meeting.

D. Ag Discovery Center (Mark) – Agreement of Sale on the land is in process.
