

## **ORDER OF COURT**

AND NOW, this <u>35</u> day of November 2025, upon review and consideration of the Petition of Beverly L. Boyd, Adams County Prothonotary, and pursuant to 42 P.S. § 21071.1, which authorizes the Prothonotary to increase fees consistent with the percentage of increase in the Consumer Price Index for Urban Workers for the immediate three (3) year period proceeding the last increase, the Court takes judicial notice that the proposed increase in fees of 6.2% or less is within the stated percentage increase.

It is hereby ORDERED and DECREED that the Court approves the increase in the fee schedule for the Prothonotary effective January 1, 2026 as per the fee schedule that follows hereto and is marked as Exhibit B to the Petition. It is directed that this Order shall be filed and published on the Adams County website and in the Adams County Legal Journal and Pennsylvania Bulletin.
