#### Community Vaccination Center

The Adams County Community Vaccination Center (CVC) on the 1<sup>st</sup> level of the Adams County 911 Center has been prepared and **once COVID-19 vaccine supply is available** will be opened to administer vaccinations by *appointment only* through My Wellspan <u>www.wellspan.org</u>. The Community Vaccination Center is a collaboration between Wellspan and Adams County government in an effort to maximize vaccinations in a suitable and convenient setting. Wellspan will be supplying the appointment portal, the vaccine, staff, and registration. Adams County is supplying the venue, maintenance, traffic control and security.

*Vaccinations at the CVC will* be by appointment only. There will be no walk-in service. Appointments can be made on My Wellspan <u>www.wellspan.org</u> or by calling the Wellspan Covid – 19 Hotline at 855-851-3641. Clients will park, enter the building by the front entrance, register, be directed to a vaccination line, receive the vaccine, rest for 15 minutes to ensure there is no negative reaction, and exit by the north side door. It is anticipated that the Adams County CVC will

operate for several months at that location. Wellspan vaccine supply is dictated by the State providing it to them.

It is obvious that obtaining vaccine appointments has been a frustrating experience for many of our residents. We all have friends and family awaiting vaccination and are hopeful that placing this county owned facility in operation as soon as vaccine is available will make the process more available and convenient for Adams County residents.

### **Free Vaccination Transportation Available**

Our community transportation entity rabbittransit, has partnered with area organizations to offer free shared ride transportation service to any community member who needs transportation to and from their scheduled COVID-19 vaccination appointment. As the COVID vaccine continues to become more available, and the Community Vaccination Center is prepared to open at the county 911 Center, rabbittransit is ensuring that transportation is not a barrier in getting vaccinated and is ready to assist the community with transportation to reach vaccine appointments.

Advance reservations for rides are required. When scheduling a shared ride trip to a vaccination site, riders must have a confirmed COVID-19 vaccine appointment at the location they are requesting transportation. Residents will need to call rabbittransit no later than noon the business day prior to their appointment. Transit staff will assist individuals through the reservation process.

# **CHIRP Hospitality Program Grants**

You may have heard about Governor Wolf's announcement establishing \$145 million in financial aid for Pennsylvania's hospitality industry. The Adams County Economic Development Corporation will be administering and offering this much-needed grant program to Adams County's hospitality industry. Adams County's portion of the funding is \$1.16 million. The program is called the COVID-19 Hospitality Industry Recovery Program (CHIRP). CHIRP will open to applications from Adams County's eligible hospitality businesses on Monday, March 15.

The purpose of the grant is to reimburse eligible applicants for reduction of revenues. Eligible applicants with NAICS code beginning with 721 or 722 on your corporate tax return. To be eligible for the grant the applicant must demonstrate that gross receipts for the first, second, third and fourth guarter in 2020 were reduced at least 25% from 2019. If the applicant was not in business during the first or second quarter of calendar year 2019, but was in business during the third and fourth quarters of calendar year 2019, the applicant had gross receipts during the first, second, third or fourth quarter of calendar year 2020 that demonstrate at least a 25% reduc-GRANTS tion from the applicant's gross receipts

during the third or

fourth quarter of calendar year 2019. The applicant must employ less than 300, has a maximum tangible net worth of not more than \$15 million, and was in operation on February 15, 2020 and remains in operation and does not intend to permanently cease operations within one year of the date of application. The minimum grant award is \$5000, and the maximum award is \$50,000. CHIRP's on-line portal will open on March 15.

#### **Mercy Recovery House Open House**

The *Mercy House Ribbon Cutting & Open House* will be held on May 14, 2021 from 12:00-4:00. The ribbon cutting and program will begin at 12:00. The facility will be open for touring following the program until 4:00. The 1<sup>st</sup> floor will be a community walk-in center. The 2<sup>nd</sup> floor will provide residential accommodations for seven male residents enrolled in the treatment program and working full-time day jobs. Weekend and evening participation in treatment and counseling programs are required to be a resident.

This once deteriorating and vacant county owned property, formerly a part of St Francis Xavier, that was historically occupied by The Sisters of Mercy, was completely renovated, in a large part through \$1.2M in grant funding and generous donations from the community. The renovations include an elevator which will serve that venue and could later serve the former St Francis Xavier School Building if appropriate. Mercy House will be administered by the RASE Project, who successfully administer similar programs in Lancaster, Harrisburg & York. Adams County will receive rental reimbursement by terms of a lease between the RASE Project and Adams County. The ribbon cutting for this facility will mark a significant step for our community in acknowledging and addressing addiction recovery!

# **Adams County Historical Society Groundbreaking**

An important milestone for Adams County history was achieved on Sunday with the groundbreaking ceremony for the new Adams County Historical Society complex overlooking Barlow's Knoll on the Biglerville Road. The former Adams County Prison site was donated to the ACHS from Adams County several decades ago. Adams County recently contributed \$1M in Pillow Tax funds toward the \$5.5M project. We are happy to report that the ACHS Capital Campaign is rapidly approaching the Building Campaign goal of \$5.5M.

The new headquarters will enable the ACHS to preserve, catalog, store, display and interpret Adams County History. There will be a focus on student education - especially geared toward Adams County Youth. The building will have an events center on the 2<sup>nd</sup> floor that will increase events space for the community while creating additional revenue opportunities for the society. Construction of the first building to alleviate current storage limitations is expected to commence this spring and be completed by early fall. It is hoped the remainder of the project will be completed in 2022. # **Emergency Rental / Utility Relief**

Adams County has applied for and received \$6,774,933 in Rental Assistance funds from the Federal Government through the State.

The Commonwealth

of Pennsylvania received \$569,807,659.70 in total through section

501 of Division N of the Consolidated Appropriations Act, 2021, Pub. L.

No. 116-260 (Dec. 27, 2020). The Rental and Utility Assistance Grant Pro-

gram component of Act 1 of 2021, signed into law by Governor Wolf on February

5, 2021, gives the Department of Human Services (DHS) the authority to establish program-

matic and eligibility guidelines for the Emergency Rental Assistance Program (ERAP).

ERAP monies are for use in Fiscal Year (FY) 2020-2021. ERAP will provide families and individuals financial assis-

tance for rent including: rent, rental arrears, utilities and home energy costs, utility and home energy costs arrears, and

other expenses related to housing incurred due directly or indirectly to COVID-19, and housing stability services to eligible households. Counties will have until December 31, 2021 to utilize their allocations.

Adams County has appointed South Central Community Action Agency (SCCAP) as the administrator of the funds. Applications are being received as guidelines and policies at the state level are still being established and revised. Go to <u>www.sccap.org</u> for information and to download ERAP forms. The forms can be picked up or dropped off at SCCAP offices on Stratton Street in Gettysburg and South Main Street in Chambersburg.
