TWO ARRESTED FOR ATTEMPTED HOMICIDE

District Attorney Brian Sinnett announced this morning that Jose Arredondo Ponce, 19, of Gardners, and Jonathan Lua, 17, of New Oxford were charged with Attempted Homicide, Conspiracy, and related charges following a shooting that occurred in New Oxford, Adams County, Pennsylvania on June 12, 2021. It is alleged that Arredondo and Lua were together that night engaged in an argument on social media with the victim, they went together to meet the victim outside of his residence, they waited as the victim approached, Lua shot the victim when he walked into range, and Arredondo drove himself and Lua from the scene. Assistant District Attorney Miranda Blazek will prosecute the case. See the attached Criminal Complaints and Affidavits of Probable Cause.

The Adams County District Attorney's Office thanks Officers Darryl Keller and Doug Fishel and the Eastern Adams Regional Police Department, as well as the Adams County Detectives for their investigation of this case. We also thank our emergency services personnel for their diligent efforts in providing life-saving medical care to the victim.

Both defendants are being held without bail. Preliminary hearings are scheduled for June 30, 2021 at 11:00 a.m. by video. In this case, as with all criminal prosecutions, the accused are presumed innocent until proven guilty.

AFFIDAVIT OF PROBABLE CAUSE

I am your Affiant, Detective Darryl Keller of the Eastern Adams Regional Police Department, (EARP) providing police service to New Oxford Borough and Oxford Township, Adams County Pennsylvania. I have been employed by EARP for the past 6 years, and have investigated various assaults, shootings, and other criminal activity.

On June 12, 2021 at 2155 hours Officers from EARP were dispatched to an incident involving a victim with a gunshot wound to his abdomen. The 19-year-old male gunshot victim was found by myself and CPL Cuffley lying on the sidewalk in front of 75 Oak Drive, Apt E. New Oxford, Pennsylvania, (Oxford Township). The victim was in the company of Floyd S Zirkle 75 Oak Drive Apt E New Oxford, Pennsylvania, where the victim fell after receiving the bullet wound to his left lower abdomen.

I asked the victim multiple times who may have shot him, and he responded multiple times that he did not know who did it. A cell phone was found near him that he identified as his. I took the phone for safe keeping as he was going to be airlifted to York Hospital as a result of his gunshot wound. The male victim was identified as Hilario LUPIAN LUA W/H/M (DOB 2/11/2002) by the information he provided to EMS and myself, and he is familiar to the Officers at EARP from prior contact with him.

Zirkle related to me that he witnessed the activity of Lupian Lua just prior to the sound of the of a single gunshot. He observed Lupian Lua walking towards Oak Drive from the area of apartment 79 and heard Lupian Lua whistle at a truck with a loud exhaust on Oak Drive in an attempt to make contact with the occupants of the truck. Zirkle described the truck as a light colored pick-up and saw it rapidly depart the area just after hearing the sound of a gunshot. This information was recounted again to me by Adams County Detective Wade Lauer who did a follow up interview with Zirkle on June 13, 2021

Officers secured the scene and provided first aid measures to Lupian Lua until EMS units arrived and assumed a higher level of care. After that I canvased the immediate area for security video cameras and found a photo of a large white truck on Oak Drive provided by Sueanne Senft residing at 95 Oak Drive, New Oxford Pennsylvania, just East of the incident area. This image was captured at 2153 hours by her home security surveillance cameras.

On June 13, 2021 at approximately 0300 hours Lupian Lua's sister, Yadira Lupian Lua contacted me by phone and advised that she accessed her brother's Instagram account and provided names of Jose Arredondo, Alex Sandoval, and Jonathan Lua, and stated that these three had been arguing with her brother on social media prior to the shooting. She related that the messages included an invitation from Jonathan Lua to Lupian Lua to come out and meet him. Yadira provided this preliminary information of whom she believed may have been involved in the shooting that was later confirmed when after a search warrant was executed, Adams County Detective Eric Beyer downloaded the contents of Lupian Lua's black APPLE I Phone.

Det Beyer located an Instagram profile of "Hoesay.15" in which a white pick-up truck is depicted matching the witness Zirkle's description, and the photo captured at 95 Oak Drive. The profile Hoesay.15 is consistent with the name of Jose SA Arredondo Ponce W/H/M (DOB 3/29/02).

Yadira also provided an image from Jonathan Lua's social media, Facebook, where he updated his profile picture after the shooting with three typed lines of lyrics from a King Von song, titled "2 am":

"Make him dance, ain't talking bout tiktok AOPC 411C - Rev. 07/18 <u>क्रिया क्रम</u>

Shoot up his whip, it won't help at no pitstop Speak on the guys, that's a why you can get dropped"

Jose Arredondo commented on that post by Jonathan Lua: "DLC shit [devil face emoji] really livin what the song says [100 underlined emoji]"

Yadira related that she interpreted this post and comment as bragging about Hilario Lupian Lua's shooting. I researched this song using Google Chrome at the EARP station and discovered by viewing the video, and listening to the lyrics, that this is gangster rap, and the song is about gang violence and a murder involving a shooting and killing the witness.

On June 13, 2021 I searched Facebook and found Jose Arredondo's profile named "Jose Arredondo (Hoesay)" and his profile image that matches the JNET driver's photo of Jose SA Arredondo Ponce. The JNET record has the full name, including PONCE. The Facebook profile image also shows the 2016 Chevrolet pick-up truck, and lists Arredondo's town as Gardners, PA. The JNET driver's license check provided an address for Arredondo of 5 Latimore Road, Gardners, Pennsylvania. At approximately 1300 hours on June 13, 2021 Adams County Detectives Lauer and Beyer drove past 5 Latimore Road, Gardners and confirmed that a white truck was parked in the driveway with PA registration ZRM 3182. A registration check provided by the Adams County Detectives of PA ZRM 3182 returned a 2016 Chevrolet pick-up truck consistent with the photos from 95 Ook Drive. The truck is registered to Felix Arredondo W/H/M (DOB 4/27/65) residing at 5 Latimore Road Gardners, PA 17324.

On June 13, 2021 Adams County Detectives Beyer and Lauer conducted a neighborhood canvas searching for surveillance cameras and/or additional witnesses. Detective Beyer reported that he contacted Joseph Slothour at 70 Oak Drive. Mr. Slouther stated that at approximately 2130 hours, he heard fireworks being ignited by a neighbor, and a few minutes later he heard an additional two pops, which he thought sounded like black powder pistol being fired.

Tim DeShong of 85 Walker Drive stated that he heard the shooting and observed a "ratty loud" truck with square taillights driving on Oak Drive towards York Road, away from the scene.

On June 14, 2021 Adams County Detective Wade Lauer interviewed Jenny Lua and she relates that both Jonathan Sandoval Lua and Hilario Lupian Lua, the victim are her cousins. She did not know that Hilario had been shot. She was visibly upset to learn about the shooting. Jenny stated that Jose Arredondo and Jonathan Lua picked her up at her house in Abbottstown, PA around 1800 hours on Saturday June 12, 2021. They picked her up in Arredondo's white pickup truck, Arredondo was driving, and Jonathan Lua was in the front passenger seat, with her in the rear passenger seat. She reported that they went to a store in Hanover. She recalled that Jonathan Lua had a cell phone, but she was not aware of the disagreement between Hilario Lupian Lua and Jonathan Lua.

On June 14, 2021, a Search Warrant obtained by Officer Fishel was executed by Fishel, Beyer, and me at the residence of Jose Arredondo 5 Latimore Road, Gardners PA, and the 2016 white Chevrolet pick up truck was seized and transported to J & A Towing for impound.

While at the residence, consent to search was requested, and the consent form signed by Maria

Arredondo (sister of Jose Arredondo) with Felix Arredondo (Jose Arredondo's father). The search was

performed by Adams County Detective Beyer and myself, of the outside area of the house where many .22 casings (fired rimfire ammunition) were observed. A partial box of loaded Aguila .22 Long Rifle subsonic 40 grain solid lead bullets and American Eagle .22 Long Rifle High Velocity 38 grain copper plated hollow point ammunition were recovered. The .22 caliber of the bullets is consistent with the small entrance wound that the victim sustained from this shooting.

Jose Arredondo arrived at the residence a short time after that and was interviewed by Detective Beyer, Officer Fishel and me. After Miranda warnings he agreed to talk about the shooting. He admitted to driving his white Chevrolet pick up with Jonathan Lua to the Oak Drive area after Jonathan Lua and the victim Lupian Lua were arguing on social media, the Instagram APP. He assumed that he and Jonathan Lua were going to meet Lupian Lua to in his words "throw down" (fight). He said that he did not know that Jonathan Lua had a gun. He stated that Jonathan Lua was the one that "pulled the trigger". The interview was documented on my body worn camera. Arredondo agreed to be transported to the EARP station to provide a second interview and provide a written statement. At the station he was provided the Miranda Warnings again. The interview was consistent with the first one done at his house, with these additional aspects: He diagramed the crime scene on an overhead photograph of the apartment complex, outlining and marking the position where he parked the truck, where he and Jonathan Lua were standing by the truck just west the apartment entrance on Oak Drive, and where he estimated the victim was when he was shot. Arredondo was then transported to the crime scene at Oak Drive, and he demonstrated where he and Jonathan Lua were standing. He showed Officer Fishel where Lupian Lua was physically standing when he was shot. Fishel measured the distance and documented the distance of 30 yards using a measuring wheel.

On June 16, 2021, Officer Fishel and I performed another review of the phone contents of Arredondo's phone and found some messages from him to his girlfriend, whose profile name is "Gisell". The messages sent from Jose Arredondo to Gisell said "Cleaned all the bullets so they don't have our prints" (6/13/21@1258 hrs) "Jon shot him", (6/13/21@0154 hrs) "Ima delete everything" (6/13/21@0209). Gisell replied: "why", Arredondo responded: "In case."

At 0730 on 6/16/2021Jose Arredondo voluntarily came to EARP station to meet with me again, and after Miranda warnings he was interviewed by Officer Fishel and myself. He was asked to explain the aforementioned messages to Gisell. He provided a verbal and written statement that Jonathan Lua told him that he cleaned the bullets to remove his fingerprints. Arredondo said that Jonathan Lua told him about the bullets while in the truck travelling to the Oak Drive address to find Lupian Lua. When confronted as to the wording "our prints" Arredondo had no explanation. Officer Fishel asked him why he found it necessary to tell his girlfriend that "Jon shot him", and he replied that he was worried. Then Arredondo was asked why he would tell her "Ima delete everything... In case" and Arredondo said that he knew the police would be looking for him.

On June 16, 2021 at 1310 hours Officer Fishel and myself met with Hilario Lupian Lua in his hospital room 3303 at the York Hospital. He detailed the events of the shooting and identified the actors, stating that Jose Arredondo was driving his white truck and parked just prior to (west of) the entrance to the apartment complex on Oak Drive. Lupian Lua said that Jonathan Lua was in the passenger seat of Arredondo's truck. Both Arredondo and Jonathan Lua got out of the truck with Arredondo standing in front of the parked truck. Lupian Lua stated that Jonathan Lua was behind the open passenger door of the truck with the window down, taking a resting shooting position with his arms through the open

passenger door window. Words were exchanged as Lupian Lua walked towards the parked truck. He stated he was able to clearly see Jonathan Lua from the streetlights in the parking area.

As Lupian Lua approached the area of 75 Oak Drive, walking from his residence at 79 Oak Drive in a northern direction in the parking lot, he stated he heard a single shot ring out and he said that he knew he was hit. He ran to a parked car in front of 75 Oak Drive in case another shot was forthcoming. At that point he reports that Arredondo and Jonathan Lua left the scene very quickly in Arredondo's truck. He stated a neighbor helped him until PD arrived. He stated that he felt the wound in his abdomen and fell down and started to vomit he said that he was sweating. He did not realize the severity, or mortality of the gunshot wound until the surgeons at York Hospital explained that he came close to death from the wound.

On June 23, 2021, Officer Fishel and I attempted to interview Jonathan Lua at Manos House, but he declined to provide any statement.

AFFIDAVIT OF PROBABLE CAUSE

I am your Affiant, Detective Darryl Keller of the Eastern Adams Regional Police Department, (EARP) providing police service to New Oxford Borough and Oxford Township, Adams County Pennsylvania. I have been employed by EARP for the past 6 years, and have investigated various assaults, shootings, and other criminal activity.

On June 12, 2021 at 2155 hours Officers from EARP were dispatched to an incident involving a victim with a gunshot wound to his abdomen. The 19-year-old male gunshot victim was found by me and CPL Cuffley lying on the sidewalk in front of 75 Oak Drive, Apt E. New Oxford, Pennsylvania, (Oxford Township). The victim was in the company of Floyd S Zirkle 75 Oak Drive Apt E New Oxford, Pennsylvania, where the victim fell after receiving the bullet wound to his left lower abdomen.

I asked the victim multiple times who may have shot him, and he responded multiple times that he did not know who did it. A cell phone was found near him that he identified as his. I took the phone for safe keeping as he was going to be airlifted to York Hospital as a result of his gunshot wound. The male victim was identified as Hilario LUPIAN LUA W/H/M (DOB 2/11/2002) by the information he provided to EMS and me, and he is familiar to the Officers at EARP from prior contact with him.

Zirkle related to me that he witnessed the activity of Lupian Lua just prior to the sound of the of a single gunshot. He observed Lupian Lua walking towards Oak Drive from the area of apartment 79 and heard Lupian Lua whistle at a truck with a loud exhaust on Oak Drive in an attempt to make contact with the occupants of the truck. Zirkle described the truck as a light-colored pick-up and saw it rapidly depart the area just after hearing the sound of a gunshot. This information was recounted again to me by Adams County Detective Wade Lauer who did a follow up interview with Zirkle on June 13, 2021

Officers secured the scene and provided first aid measures to Lupian Lua until EMS units arrived and assumed a higher level of care. After that I canvased the immediate area for security video cameras and found a photo of a large white truck on Oak Drive provided by Sueanne Senft residing at 95 Oak Drive, New Oxford Pennsylvania, just East of the incident area. This image was captured at 2153 hours by her home security surveillance cameras.

On June 13, 2021 at approximately 0300 hours Lupian Lua's sister, Yadira Lupian Lua contacted me by phone and advised that she accessed her brother's Instagram account and provided names of Jose Arredondo, Alex Sandoval, and Jonathan Lua, and stated that these three had been arguing with her brother on social media prior to the shooting. She related that the messages included an invitation from Jonathan Lua to Lupian Lua to come out and meet him. Yadira provided this preliminary information of whom she believed may have been involved in the shooting that was later confirmed when after a search warrant was executed, Adams County Detective Eric Beyer downloaded the contents of Lupian Lua's black APPLE I Phone.

Det Beyer located an Instagram profile of "Hoesay.15" in which a white pick-up truck is depicted matching the witness Zirkle's description, and the photo captured at 95 Oak Drive. The profile Hoesay.15 is consistent with the name of Jose SA Arredondo Ponce W/H/M (DOB 3/29/02).

Yadira also provided an image from Jonathan Lua's social media, Facebook, where he updated his profile picture after the shooting with three typed lines of lyrics from a King Von song, titled "2 am":

"Make him dance, ain't talking bout tiktok

Shoot up his whip, it won't help at no pitstop Speak on the guys, that's a why you can get dropped"

Jose Arredondo commented on that post by Jonathan Lua: "DLC shit [devil face emoji] really livin what the song says [100 underlined emoji]"

Yadira related that she interpreted this post and comment as bragging about Hilario Lupian Lua's shooting. I researched this song using Google Chrome at the EARP station and discovered by viewing the video, and listening to the lyrics, that this is gangster rap, and the song is about gang violence and a murder involving a shooting and killing the witness.

On June 13, 2021 I searched Facebook and found Jose Arredondo's profile named "Jose Arredondo (Hoesay)" and his profile image that matches the JNET driver's photo of Jose SA Arredondo Ponce. The JNET record has the full name, including PONCE. The Facebook profile image also shows the 2016 Chevrolet pick-up truck, and lists Arredondo's town as Gardners, PA. The JNET driver's license check provided an address for Arredondo of 5 Latimore Road, Gardners, Pennsylvania. At approximately 1300 hours on June 13, 2021 Adams County Detectives Lauer and Beyer drove past 5 Latimore Road, Gardners and confirmed that a white truck was parked in the driveway with PA registration ZRM 3182. A registration check provided by the Adams County Detectives of PA ZRM 3182 returned a 2016 Chevrolet pick-up truck consistent with the photos from 95 Ook Drive. The truck is registered to Felix Arredondo W/H/M (DOB 4/27/65) residing at 5 Latimore Road Gardners, PA 17324.

On June 13, 2021 Adams County Detectives Beyer and Lauer conducted a neighborhood canvas searching for surveillance cameras and/or additional witnesses. Detective Beyer reported that he contacted Joseph Slothour at 70 Oak Drive. Mr. Slouther stated that at approximately 2130 hours, he heard fireworks being ignited by a neighbor, and a few minutes later he heard an additional two pops, which he thought sounded like black powder pistol being fired.

Tim DeShong of 85 Walker Drive stated that he heard the shooting and observed a "ratty loud" truck with square taillights driving on Oak Drive towards York Road, away from the scene.

On June 14, 2021 Adams County Detective Wade Lauer interviewed Jenny Lua and she relates that both Jonathan Sandoval Lua and Hilario Lupian Lua, the victim are her cousins. She did not know that Hilario had been shot. She was visibly upset to learn about the shooting. Jenny stated that Jose Arredondo and Jonathan Lua picked her up at her house in Abbottstown, PA around 1800 hours on Saturday June 12, 2021. They picked her up in Arredondo's white pickup truck, Arredondo was driving, and Jonathan Lua was in the front passenger seat, with her in the rear passenger seat. She reported that they went to a store in Hanover. She recalled that Jonathan Lua had a cell phone, but she was not aware of the disagreement between Hilario Lupian Lua and Jonathan Lua.

On June 14, 2021, a Search Warrant obtained by Officer Fishel was executed by Fishel, Beyer, and me at the residence of Jose Arredondo 5 Latimore Road, Gardners PA, and the 2016 white Chevrolet pick up truck was seized and transported to J & A Towing for impound.

While at the residence, consent to search was requested, and the consent form signed by Maria

Arredondo (sister of Jose Arredondo) with Felix Arredondo (Jose Arredondo's father). The search was performed by Adams County Detective Beyer and myself, of the outside area of the house where many .22 casings (fired rimfire ammunition) were observed. A partial box of loaded Aguila .22 Long Rifle subsonic 40 grain solid lead bullets and American Eagle .22 Long Rifle High Velocity 38 grain copper plated hollow point ammunition were recovered. The .22 caliber of the bullets is consistent with the small entrance wound that the victim sustained from this shooting.

Jose Arredondo arrived at the residence a short time after that and was interviewed by Detective Beyer, Officer Fishel and me. After Miranda warnings he agreed to talk about the shooting. He admitted to driving his white Chevrolet pick up with Jonathan Lua to the Oak Drive area after Jonathan Lua and the victim Lupian Lua were arguing on social media, the Instagram APP. He assumed that he and Jonathan Lua were going to meet Lupian Lua to in his words "throw down" (fight). He said that he did not know that Jonathan Lua had a gun. He stated that Jonathan Lua was the one that "pulled the trigger". The interview was documented on my body worn camera. Arredondo agreed to be transported to the EARP station to provide a second interview and provide a written statement. At the station he was provided the Miranda Warnings again. The interview was consistent with the first one done at his house, with these additional aspects: He diagramed the crime scene on an overhead photograph of the apartment complex, outlining and marking the position where he parked the truck, where he and Jonathan Lua were standing by the truck just west the apartment entrance on Oak Drive, and where he estimated the victim was when he was shot. Arredondo was then transported to the crime scene at Oak Drive, and he demonstrated where he and Jonathan Lua were standing. He showed Officer Fishel where Lupian Lua was physically standing when he was shot. Fishel measured the distance and documented the distance of 30 yards using a measuring wheel.

On June 16, 2021, Officer Fishel and I performed another review of the phone contents of Arredondo's phone and found some messages from him to his girlfriend, whose profile name is "Gisell". The messages sent from Jose Arredondo to Gisell said "Cleaned all the bullets so they don't have our prints" (6/13/21@1258 hrs) "Jon shot him", (6/13/21@0154 hrs) "Ima delete everything" (6/13/21@0209). Gisell replied: "why", Arredondo responded: "In case."

At 0730 on 6/16/2021Jose Arredondo voluntarily came to EARP station to meet with me again, and after Miranda warnings he was interviewed by Officer Fishel and myself. He was asked to explain the aforementioned messages to Gisell. He provided a verbal and written statement that Jonathan Lua told him that he cleaned the bullets to remove his fingerprints. Arredondo said that Jonathan Lua told him about the bullets while in the truck travelling to the Oak Drive address to find Lupian Lua. When confronted as to the wording "our prints" Arredondo had no explanation. Officer Fishel asked him why he found it necessary to tell his girlfriend that "Jon shot him", and he replied that he was worried. Then Arredondo was asked why he would tell her "Ima delete everything... In case" and Arredondo said that he knew the police would be looking for him.

On June 16, 2021 at 1310 hours Officer Fishel and myself met with Hilario Lupian Lua in his hospital room 3303 at the York Hospital. He detailed the events of the shooting and identified the actors, stating that Jose Arredondo was driving his white truck and parked just prior to (west of) the entrance to the apartment complex on Oak Drive. Lupian Lua said that Jonathan Lua was in the passenger seat of Arredondo's truck. Both Arredondo and Jonathan Lua got out of the truck with Arredondo standing in front of the parked truck. Lupian Lua stated that Jonathan Lua was behind the open passenger door of

the truck with the window down, taking a resting shooting position with his arms through the open passenger door window. Words were exchanged as Lupian Lua walked towards the parked truck. He stated he was able to clearly see Jonathan Lua from the streetlights in the parking area.

As Lupian Lua approached the area of 75 Oak Drive, walking from his residence at 79 Oak Drive in a northern direction in the parking lot, he stated he heard a single shot ring out and he said that he knew he was hit. He ran to a parked car in front of 75 Oak Drive in case another shot was forthcoming. At that point he reports that Arredondo and Jonathan Lua left the scene very quickly in Arredondo's truck. He stated a neighbor helped him until PD arrived. He stated that he felt the wound in his abdomen and fell down and started to vomit he said that he was sweating. He did not realize the severity, or mortality of the gunshot wound until the surgeons at York Hospital explained that he came close to death from the wound.

On June 23, 2021, Officer Fishel and I attempted to interview Jonathan Lua at Manos House, but he declined to provide any statement.
