WE, the County Board of Elections of Adams County, Commonwealth of Pennsylvania, do hereby make known and give this notice to the electors of the County aforesaid, that a GENERAL PRIMARY ELECTION will be held in the County of Adams, on

TUESDAY, APRIL 23, 2024

It being the fourth Tuesday in April (Polls to be opened at 7 am and will close at 8 pm), Republican and Democratic, will nominate candidates for the following offices:

One (1) President of the United States
One (1) United States Senator
One (1) Attorney General
One (1) Auditor General
One (1) State Treasurer
One (1) Representative in Congress – 13th District
One (1) Senator in the General Assembly – 33rd District
One (1) Representative in the General Assembly – 91st District
One (1) Representative in the General Assembly – 193rd District

The following are the party offices and number to be elected in the General Primary:

Three (3) Delegate to the Democratic National Convention

Three (3) Delegate to the Republican National Convention
Three (3) Alternate Delegate to the Republican National Convention

NOTICE - DUE TO THE ELECTRONIC VOTE-COUNTING SYSTEM, THE BALLOT INSTRUCTIONS WILL READ:

1. TO VOTE YOU MUST BLACKEN THE OVAL COMPLETELY. An oval blackened to the left of the name of any candidate indicates a vote for that candidate.
2. To vote for a person whose name is NOT on the ballot, you must blacken the oval completely to the left of the line provided and write or print the name in the blank space provided for that purpose.
3. If you make a mistake, ask for a new ballot.
4. USE ONLY BLACK INK PEN.
5. DO NOT FOLD THE BALLOT unless voting by absentee ballot or mail-in.

WARNING: If you receive an absentee or mail-in ballot and return your voted ballot by the deadline, you may not vote at your polling place on election day. If you are unable to return your voted absentee or mail-in ballot by the deadline, you may only vote a provisional ballot at your polling place on election day, unless you surrender your absentee or mail-in ballot and envelope to the Judge of Elections to be voided to vote by regular ballot.

Official Pre-Canvass Meeting Notice

Public notice is hereby given that the Adams County Pre-Canvass Meeting will occur at 7:00 a.m. on April 23, 2024 in the Adams County Election Office located at 230 Greenmyer Lane, Gettysburg, for purpose of pre-canvassing the ballots. No members of the general public will be permitted to observe the pre-canvass in person, and only one authorized representative from each candidate in an election shall be permitted to remain in the room in which the absentee and mail-in ballots are pre-canvassed. CDC guidelines will be strictly followed, and all representatives will be required to follow County sanitation protocols if appearing in person. Representatives will have the option of viewing the pre-canvass meeting through the Microsoft Teams online software. You will be able to watch a live feed of the process and interact with County staff through Microsoft Teams. The County Board of Elections will meet at 9:00 a.m. Friday, April 26, 2024 to compute and canvass the returns of the Primary Election.
